

RESOLUTION NO. 2020-R-071

A RESOLUTION AMENDING THE CITY COUNCIL ELECTION ORDER DATED FEBRUARY 10, 2020 AND ORDERING A GENERAL ELECTON TO BE HELD IN THE CITY OF ATHENS, TEXAS ON NOVEMBER 3, 2020 FOR THE PURPOSE OF ELECTING ONE COUNCILMEMBER PLACE 2, ONE COUNCILMEMBER PLACE 3, AND ONE COUNCILMEMBER PLACE 4; FOR THE CITY COUNCIL OF THE CITY OF ATHENS, TEXAS

WHEREAS, the City Council of the City of Athens previously passed Resolution 2020-R-011 on February 10, 2020 to order a General election for May 2, 2020 for the purpose of electing one Council Member, Place 2; one Council Member, Place 3; and one Council Member, Place 4 for the City Council of the City of Athens, Texas.

WHEREAS, on March 13, 2020, the Governor of Texas certified that the novel coronavirus (COVID-19) poses an imminent threat of disaster and declared a state of disaster for all counties in Texas; and

WHEREAS, on March 18, 2020, the Governor of Texas issued a Proclamation to suspend various statutes to allow political subdivisions of the state that would otherwise hold elections on May 2, 2020, to move their general and special elections for 2020 to the next uniform election date, occurring on November 3, 2020; and

WHEREAS, on March 23, 2020, the City Council approved Resolution No. 2020-R-036 postponing the City of Athens May 2, 2020 General Election, to November 3, 2020 preserving candidate filings; and

WHEREAS, On July 27, 2020 Governor Greg Abbott issued a Proclamation suspending Section 85.001(a) of the Texas Election Code to expand the early voting period for the November 3, 2020 elections allowing early voting to begin October 13, 2020 through October 30, 2020.

WHEREAS, the City Council finds it necessary to approve this resolution amending the February 10, 2020 Election Order of the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ATHENS, TEXAS THAT:

An election is hereby ordered to be held in the City of Athens, Texas on November 3, 2020, being the first Tuesday in November, between the hours of 7:00 a.m. and 7:00 p.m. at Henderson County Election Center, 201 East Larkin St., Athens, Texas for the purposes of electing the following officials for the term thereafter set;

Electing one Council Member, Place 2; for a term of two years
 One Council Member, Place 3; for a term of two years
 One Council Member, Place 4 for a term of two years

Any individual seeking to vote in the November 3, 2020, election must register to vote by October 5, 2020.

Denise Hernandez, Henderson County Election Administrator, is hereby designated as the Early Voting Clerk for said election.
