

RESOLUTION NO. 2020- R-011

A RESOLUTION ORDERING A GENERAL ELECTION TO BE HELD IN THE CITY OF ATHENS, TEXAS ON MAY 2, 2020 FOR THE PURPOSE OF ELECTING ONE COUNCILMEMBER PLACE 2, ONE COUNCILMEMBER PLACE 3, AND ONE COUNCILMEMBER PLACE 4; FOR THE CITY COUNCIL OF THE CITY OF ATHENS, TEXAS

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ATHENS, TEXAS THAT:

An election is hereby ordered to be held in the City of Athens, Texas on May 2, 2020, being the first Saturday in May, between the hours of 7:00 a.m. and 7:00 p.m. at Henderson County Election Center, 201 East Larkin St., Athens, Texas for the purposes of electing the following officials for the term thereafter set;

Electing one Council Member, Place 2; for a term of two years
One Council Member, Place 3; for a term of two years
One Council Member, Place 4 for a term of two years

Denise Hernandez, Henderson County Election Administrator, is hereby designated as the Early Voting Clerk for said election.

As required under Section 85.005 (d), Election Code, early voting by personal appearance at the main early voting polling place shall be conducted for at least twelve (12) hours on two (2) weekdays if the early voting period consists of six (6) or more weekdays; therefore, early voting by personal appearance shall be conducted for twelve (12) hours on the first Monday and following Monday of the early voting period, from 7:00 a.m. until 7:00 p.m. April 20, 2020 and April 28, 2020.

The official ballot for said May 2, 2020 election shall be prepared in accordance with the Texas Election Code. Paper ballots shall be provided for use in early voting by mail, as approved by the Secretary of State. Only qualified voters residing in the City of Athens shall be eligible to vote in said election.

A notice of said election shall be given in accordance with the provisions of the Texas Election Code and returns of such notice shall be made as provided for in said Code.
